- A copy of the quote for airfares and assistance from IOM or from another travel agent.
- A copy of the most recent statements for all your financial assets (e.g. a bank statement for each of your accounts) and your regular income (e.g. payslips).
- Evidence that you have raised as much as could reasonably be expected towards this airfare, and no less than 10% of the total airfare price.
- Evidence that you have no other reasonable means to obtain the amount requested for the airfare loan. This may include, but is not limited to: rejection or ineligibility for a bank loan; rejection or limits of assistance from church, ethnic or community groups.
- A statement of intention to assist in the settlement of the loan beneficiary by two people from separate families, or from a CSR group, including contact details for those people (these may be included with the character references already required).

Please note that because of limited funds, any loan granted must be fully repaid before the applicant (or immediate family) may apply for another loan.
